may be eligible for promotion and may come under zone of consideration in case of filling up the post by promotion.

An Appointing Authority considering the seniority or any other criteria may select a person appearing under zone of consideration to be promoted on the post.

A person serving on the equivalent post can be recruited by inviting panels from the concerned State Government Department/PSUs on deputation subject to terms and condition of deputation.

A person appointed on deputation under clause-5 may be eligible for absorption after putting 2 years of service. Absorption will be subject to mutual consent and terms and conditions decided by the State Government/Parent Organization.

(a) A person of the qualification as mentioned in clause-3 may be recruited through an advertisement on fixed term contract not exceeding 12 months.

(b) In case of fixed term contract Appointing Authority may relax age and experience of the candidate considering the merit.

A person retired from Government servicehaving qualification and experience as mentioned in clause-3 may also be considered for appointment as per the prevailing policies of the State Government on fixed term contract.

 (d) Appointing Authority shall be empowered to decide the terms and conditions, remuneration, renewal of contract etc. of the person appointed on contract under clause-7 (a).

A person appointed by direct recruitment shall be on probation for
a period of two years.

A person appointed for the post shall have to undergo training or any other examination as decided by the Appointing Authority. The candidate should have basic knowledge of computer applications and should be conversant with Auto cad.
